

Fall 2023 Parking FAQs

What is the deadline for signing up for the parking waitlists?

The residential and guaranteed commuter waitlists for 2023-2024 opened Wednesday, July 19. The last day to sign up and/or edit preferences for the Residential and Guaranteed Commuter waitlist is Tuesday, Aug. 1. Assignments will be made Thursday, Aug. 3.

What do I do if I am not awarded a guaranteed commuter permit?

Students who are not awarded a Guaranteed Commuter permit will be able to purchase a Standard Commuter permit.

What happened to Lot 9?

What was formerly Lot 9 will be the site of a new residence hall on campus. No parking permits will be issued for Lot 9, as construction on the residence hall will begin later this fall. Until construction begins, Lot 9 will be used as parking for students with Guaranteed Commuter permits. This temporary lot will be labeled Temporary Lot 10 and will have 234 spaces and 1 handicap space.

Where do I park if I have a Guaranteed Commuter permit in Lot 10?

To begin the semester, Guaranteed Commuter permit holders from Lot 10 will park in what was formerly Lot 9. (Former Lot 9 will be labeled as Temporary Lot 10, and representatives from Transportation Services will be present on the site to assist students in finding the correct temporary lots.) When construction is complete on Lot 26, temporary lot signs will be removed and guaranteed permit holders from Lot 10 will begin parking in Lot 10, east of Cliff Drive. This lot will have 172 spaces during the construction of the residence hall and 241 spaces when construction is complete.

When construction on the new residence hall begins, will there be a safe walking route from Lot 10 (Temporary Lot 26) to campus?

The crosswalk from Lot 10 (Temporary Lot 26) leads to a sidewalk along Cliff Drive, which connects to campus. Access to the crosswalk and the sidewalk will not be impacted by construction.

What is Lot 26?

Lot 26 is a new lot being constructed this fall for students with Commuter permits. Lot 26 is estimated to have 342 parking spaces when completed.

Where will Lot 26 be located?

Lot 26 will be located near 7th Ave. and Garnet St., north of Lot 21.

When will construction on Lot 26 be finished?

Lot 26 is expected to be completed during fall semester.

What about Lot 5?

Lot 5 will be for Guaranteed permit holders during the day and available for Rozsa patrons in the evenings. Lot 5 has 98 standard parking spaces and 10 handicap spaces. During construction of the residence hall, Lot 5 will have 89 standard spaces and 6 handicap spaces.

Where do I park if I purchase a standard commuter permit?

Commuter permits are valid in Lots 24, 26, 29 and 32. (Lot 10 will be labeled as Temporary Lot 26 until construction is complete on Lot 26.) Representatives from Transportation Services will be present on site to assist students in finding the correct temporary lots.

How will students know when construction on Lot 26 is complete and it is time to change parking lots?

Announcements to parking lot changes will be made in the Tech Today newsletter and on the Transportation Services website, and email updates will be sent directly to the impacted students from Transportation Services.

What is the Husky Campus Shuttle schedule?

The shuttle runs every 20 minutes from 7:30 a.m. to 5:00 p.m. on weekdays, beginning at the MUB and ending at the library. A detailed schedule can be found [here](#). (Note: due to low utilization, the stop behind Wadsworth Hall will be removed from the route when Lot 26 is completed.)

How will Lot 26 impact the shuttle schedule?

When Lot 26 is complete, it will be the last shuttle stop on the route before returning to the library. There will be an area in the middle of Lot 26 where the shuttle will stop for patrons. The shuttle schedule will be updated on the Transportation Services [website](#) when construction on Lot 26 is complete.

Will the Alumni Way Gateway project impact parking?

The construction on Alumni Way is expected to displace 13 metered spaces on the west end of campus. Transportation Services is working to relocate those metered parking spaces in different areas on campus. When the parking waitlist sign-up opened on July 19, students were not able to select Lot 17 as a preference. Was this issue resolved?

Yes. That issue has been resolved. A reminder email was sent Thursday, July 27 letting students know that Lot 17 is now available for selection and encouraging them to update their preferences before the deadline on Aug. 1.

What about parking for events at the Rozsa Center?

Recent parking audits concluded that approximately 450 spaces are needed for patrons, event staff, and talent at high-traffic events at the Rozsa Center.

How many spaces are currently available for event patrons in the lots near the Rozsa?

672 spaces are currently available.

How many spaces will be available for Rozsa events while the new residence hall is being constructed?

425 spaces will be available during construction of the residence hall: 90 in Lot 5, 103 in Lot 8, 60 in Lot 14, and 172 in Lot 10.

How many spaces will be available for Rozsa events after the new residence hall is completed?

512 spaces will be available when the residence hall is complete: 108 in Lot 5, 103 in Lot 8, 60 in Lot 14, and 241 in Lot 10.
