Assessment roll, 1921, for the Township of Stanton, Houghton County. The contents of this record document the owner and property description for tracts of land in Stanton Township. Included in the record is the name of the property owner, a description of the property being assessed, as well as its physical location as section, town and range; the acreage of each tract or parcel, the true cash value of each tract of real property and personal property, as well as that value as fixed by the Board of Review. Also included is an assessment as determined by the State Tax Commissioners, the number of school districts, as well as the taxes for that property (state, county, township; road repair, school and mill, and highway improvement).
