Questions: What would you like the Senate to do for you, Student Affairs?

Response: Rethink its perception of Student Affairs. See SA as genuine partners in shared governance process. Take proposals from SA seriously.

Questions: In terms of retention, how do we make sure we're balancing our desire to raise retention rates with addressing diversity, given current information on MTUs demographics? Response: We should aspire to 100% retention rates. We have to be intentional about asking tough questions. Who is withdrawing? What patterns do we see? These questions help direct us where we need to go.

2. "Cultural and Natural Resources on Michigan Tech Property: Results from Mount Ripley's Archaeology Survey," Dr. Timothy Scarlett

Presentation of results of archeological project on MTU-controlled lands. Slide presentation of archeological finds.

What do we do with the cultural and natural resources discovered?

Have we linked our planning process with informed evaluations?

Have we asked neighbors for their thoughts on our plans?

Do we wish to build relationships or continue meeting minimal legal requirements?

University is working to improve relationships with neighbors and it has an opportunity to engage these different stakeholders in conversation. With control of a lot of land, MTU needs an inventory and a plan. Does the Master Plan engage these questions?

No conclusions. It is open to conversation.

#### **Public Comments:**

Comment on the recent removal of the mask mandate. Concern that CDC website recommends places like Houghton (high transmission) wear masks indoors. Concern that we are going ahead of the CDC.

Clarification that the future date for removing masks is still ahead of the CDC recommendation.

Concern that parents of children under 5 are impacted by the decision as well.

Clarification: Response from Flex Team. Decisions was made by way of the following: 1. Follow the law; 2. Individuals need to make decisions for themselves; 3. Lean on protecting the MTU educational experience.

Question: What is the "Tech Experience?"

Response: Hands-on experience. Education not easily produced in online environments.

Question: Where in the Flex Team's goals is protect the campus community?

Response: There needs to be a balance and risk assessment as it equates with our mission at this

institution.

Question: What are students' saying about their preference on masks?

Response: It is a mixed bag.
