

Curriculum Roadmap Working Group - Mid-year Progress Report January 8, 2023

Charge

The group's charge is as follows:

Goal: Develop a roadmap to the future undergraduate curriculum offerings at Michigan Tech.

Vision: An undergraduate curriculum that:

1. reflects the character of the university,
2. serves the contemporary needs of the industries of the State of Michigan, and
3. excites and attracts students from around the country.

Premise: The faculty own the curriculum.

This group will review data, bring together faculty, administration, and other stakeholders from different units as needed to fully evaluate the status of different programs, develop preliminary recommendations regarding status of different programs, and draft a road map for the undergraduate curriculum.

Desired Outcome

Develop a guiding document tentatively titled: "Preparing Graduates for 2030 – A Curriculum Road Map for Michigan Tech." This will be an internal document that is used to guide curriculum reform and development for 2025-2030.

Progress to date

Early in the fall 2023 semester, we reviewed enrollment data for all programs from the past eight years as well as retention data and average time to degree. The Associate Deans for each college then reviewed the data for the programs in their college and flagged those that may require further attention due to low, stagnant, or declining enrollments. We discussed these programs as a group to make sure that there was consensus regarding which programs needed review.

We then prepared a data gathering form (Appendix A) to distribute to department chairs or college deans as appropriate. This form is split into three sections, one with questions relevant to programs with low or declining enrollment, one section with questions relevant to programs with high or increasing enrollment, and one with questions relevant to plans for new or revised programs or initiatives.

At the end of the semester, we sent emails (Appendix B) to the chairs and deans reviewing the purpose of the group, listing which programs in their department or college (if any) had low or declining enrollment, and inviting them to complete the form, answering the questions relevant to their programs.

Next steps

Responses to the form are due by January 31, 2024. After receiving the responses, we will review them and work with the chairs and deans to collect additional information as necessary. This data will be used to compile the next two deliverables that the working group is charged to produce:

- A “state of the curriculum” document that contains facts about our current offerings
- Classification of academic programs for prioritization by home units
